

### Particulars of Claim

IN THE SUMMARY COURT AT GEORGE TOWN Cause No. SC \_\_\_\_\_ of 2024

BETWEEN: LUIGI ORDONEZ & GREYSI ORDONEZ Plaintiff

AND: HOSHAWNA MENDEZ/L&M CARPENTRY COMPANY Defendant

I, Luigi Ordonez and my wife Greysi Ordonez on 2 April 2024 contacted L&M Carpentry Company for a quotation to purchase Kitchen Cabinets and two Vanities. Quotation grand total CI\$7,077.50. We agreed to proceed with the quotation and Mrs. Hoshawna Mendez owner of L&M Carpentry Company advised that a 50% deposit of \$3,538.75 was required and that it would take three weeks for completion of work and installation. The deposit of \$3,538.75 was sent wire transfer on 2 April 2024.

On 24 April 2024, we were expecting to hear from the company, which would have been three weeks to build the cabinets. We tried contacting the company on 1 May 2024 to ascertain the status of the cabinets and was advised by Mrs. Mendez the cabinets would be completed and install on 15 May 2024.

As time pass by, we tried contacting Mrs. Mendez numerous times by telephone and WhatsApp and no answered. Finally on the 24 May 2024 we telephoned her and she advised that the cabinets were not ready. On the 27 May 2024, my wife and I made a decision not to proceed with the order and went to the property of L& M Carpentry to request our deposit to be refunded.


Mrs. Mendez was not present and The RCIPS was contacted and Officer Walter's (RMS#15590) came to the property of L&M Carpentry and a report was made against Mrs. Mendez. She was contacted by her workers who were present and it was agreed that she would pay us back within thirty days from the date 30 June 2024. She is in breach of her own obligation with us, as she agreed to a three week delivery time.

This has been over three months' time and Mrs. Mendez shows no intension of refunding us. Therefore, we are seeking compensation of our deposit CI\$3,538.75 to be refunded and due to this inconvenience we were unable to move into our new home, which cost us additional expenses of one month's rent CI\$1,200.00
