### PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

- 1 On April 9, 2024, the Defendant borrowed \$5,000.00 and agreed to pay back the full amount plus 20% of the amount borrowed by April 26, 2024, of a total of \$6,000.00.
- 2 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that he fully understood.
- 3 On April 26, 2024, the plaintiff called the defendant about the payment and the defendant replied stating I just got the loan 3 weeks ago I can't pay until next month.
- 4 On May 24, 2024, the Defendant sister Nolvía Sanchez paid \$1,200.00 towards his balance. I WhatsApp the defendant to discover that he blocked us. The plaintiff contacted the defendant sister Nolvía Sanchez asking her to reach out to the defendant to sign the contract as he has blocked us, she replied email the contract to me, and I will have him sign it.
- 5 On Friday May 31, 2024, the plaintiff received an email from Carolina Sanchez which is the defendant sister with a picture of the contract. The plaintiff got in contact with the defendant sister informing her that the original was needed and why was the total changed she did not reply Her reply was she does not see the difference.
- 6 On Monday June 24, 2024, at about 7:30 am the defendant sister Carolina Sanchez came up to the defendant in Foster Food Fair and stated that her brother was unable to make payment today but he would be paying on Wednesday 26 June 2024.
- 7 On June 24 the plaintiff tried to contact the defendant and his sister concerning the payment and got no answer.
- 8 As of Monday July 9, 2024, the Defendant has not made any payments.
- 9 As of Monday July 8, 2024, the defendant has an outstanding balance of \$5,784.00.00 Plus \$50.00 late fee for the first day late as per contract, and as per contract 50% to be added to the balance for a total of \$7,026 and simple interest of 2.5%. A per diem of \$0.49

AND the Plaintiff claims:

- (1) The sum of \$7,026.00
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$0.49 per day
