**PARTICULARS OF CLAIM**

- 1 In April 2024 the defendant had an outstanding balance with the plaintiff in the amount of \$9,096.00.
- 2 On June 7, 2024, the defendant contacted the plaintiff stating that she knows that she owes but she does not want it to go to court because it would hamper from getting her Permanent Resident the defendant also asked the plaintiff if the interest could be reduced, and she pay \$500.00 a month. It was agreed under the conditions that every month payments of \$500.00 were made.
- 3 On June 7, 2024, a contract was given to the defendant from the plaintiff informing her that Procollect International charges 20% a month interest however we will charge her 3% providing she pays \$500.00 a month, to which the defendant agreed.
- 4 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that she fully understood.
- 5 On Monday June 24, 2024, at about 7:30 am the defendant s came up to the defendant in Foster Food Fair and stated that she would be making a payment of \$2,000.00 on Wednesday June 26, 2024
- 6 On June 24 the plaintiff tried to contact the defendant concerning the payment and got no reply no answer.
- 7 As of Tuesday July 9, 2024, the Defendant has not made any payments or has reached out to the defendant.
- 8 As of Tuesday July 9, 2024, the defendant has an outstanding balance of \$11,188.00.00 Plus \$50.00 late fee for the first day late as per contract, and as per contract 50% to be added to the balance for a total of \$16,857.00 and simple interest of 2.5%. A per diem of \$1.16

AND the Plaintiff claims:

- (1) The sum of \$16,857.00
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$1.16 per day
