PARTICULARS OF CLAIM

- 1 On Monday May 27, 2024, the Defendant borrowed \$2,457.00 and agreed to pay back the full amount plus 20% of the amount borrowed by June 24, 2024, of a total of \$2,948.00.
- 2 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action, to which the defendant stated that she fully understood.
- 3 On June 26, 2024, The Plaintiff contacted the Defendant via whatsapp about the payment, The defendant replied that she is going to deposit \$550.00 in the bank today.
- 4 On June 27, 2024, the plaintiff contacted the defendant via whatsapp concerning the payment and she replied that she was coming now to the office to pay.
- 5 On June 28, 2024, the defendant contacted via whatsapp (the messages went thru with the double blue tick but no response
- 6 As of Wednesday July 10 there has been no payment or no response from the defendant
- 7 As of Wednesday July 10, 2024, the Defendant has an outstanding balance of \$2,948.00 plus \$50.00 late fee for the first day late as per contract. and as per contract 50% to be added to the balance total \$4,497.00 and simple interest at 2.5% \$0.31 per day.

AND the Plaintiff claims:

- (1) The sum of \$4,497.00.
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$0.31 per day
