**PARTICULARS OF CLAIM**

1. The Defendant is and was at all material times a Cayman Islands carrying on business pursuant to the laws of the Cayman Islands. The Defendant’s registered office is Block 14C Parcel 24, 16 Halpine Road, George Town, PO Box 2374, Grand Cayman KY1-1104, Cayman Islands.
2. On 15 April 2024, the Defendant issued one cheque to the Cayman Islands Government for the payment of services, which was dishonoured by the bank and returned to the Government due to insufficient funds. The details of the dishonoured cheque are:

5. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.
