PARTICULARS OF CLAIM

- 1) On January 17, 2024, a lease contract was signed for \$800 for a room in the house located at 31 Peanut West Bay between the plaintiff and the defendant, which was paid until June 2024
- 2) On May 29, the plaintiff informed the defendant that his wife was coming to visit the island for 6 days, to which the defendant agreed.
- 3) On June 11, 2024, the defendant's wife was victim of insult her modesty by the owner of the house as recorded in the police report case no. 2024 - 016549
- 4) On the day of the abuse, the plaintiff and his wife left the house and the defendant did not return the deposit or the remaining rent for the month of June.
- 5) The defendant must pay the rent deposit plus the unused days of the month of June and also pay compensation for damages caused to the defendant and his wife for moving and additional relocation payments. In addition to interest for the days that he has not paid to date.

AND the Plaintiff claims:

- 1 The sum of 1100.
- 2 Interest in the sum to be assessed, calculated at the prescribed rate from to date.
- 3 Fixed costs of \$ 150, alternatively costs to be assessed.
