**ORDER**

**UPON** the summons dated 31 July 2024 of Christopher Smith and Martin Trott of R&H Restructuring (Cayman) Limited, the joint official liquidators (the "**JOLs**") of HQP Corporation Limited (in Official Liquidation) (the "**Company**"), and by subsequent letter application dated 31 July 2024 (the "**Letter Application**") (together, the "**Application**")

**AND UPON READING** the Second Affidavit of Martin Trott sworn on 29 July 2024 ("**Trott 2**") and the exhibit thereto ("**Exhibit 'MT-2'**")

**AND UPON** hearing Counsel for the JOLs

**IT IS HEREBY ORDERED THAT:**

1. The requirement for the Application to be heard on not less than 4 clear days' notice pursuant to Order 11, rule 2(4) of the Companies Winding Up Rules (2023 Consolidation) (the "**CWR**") shall be dispensed with.

This **ORDER** is filed by Walkers, Attorneys at Law, 190 Elgin Avenue George Town, Grand Cayman KY1-9001 for the JOLs whose address for service is care of their said Attorneys at Law.

2. The JOLs be and are hereby authorised to file and serve the Writ (as defined in Trott 2 and in substantially the form exhibited thereto) on the Defendants named therein and to take such steps and execute such additional documents as might be necessary or desirable for those purposes.
3. The Letter Application, Trott 2, Exhibit "MT-2" and the email from Walkers to the Court Administration dated 1 August 2024 (at 3:50pm) be sealed and kept confidential pursuant to Order 24, rule 6 of the CWR and not be made available or open to inspection by any party or other person until determination of the Writ proceedings or until further order of the Court, except with the prior leave of the Court.
4. The costs of and incidental to the Application be costs to be paid out of the assets of Company as an expense of the liquidation.
