**ORDER**

---

**UPON** the application of the Joint Official Liquidators (the **JOLs**) of Pioneer Merger Corp. (in Official Liquidation) (the **Company**) by way of Summons dated 18 September 2024

**AND UPON** reading the Eighth Affidavit of Alexander Lawson dated 18 September 2024 and Exhibit AWL-6 thereto

**AND UPON** hearing from counsel for the JOLs

**IT IS ORDERED** that:

- 1) The requirement for a Liquidation Committee to be established in respect of the Company in accordance with Order 9, Rule 1(1) of the Companies Winding Up Rules (*2023 Revision*) shall be dispensed with.
- 2) The JOLs' fees and expenses of the liquidation since the appointment of the JOLs through to dissolution of the Company, along with their remuneration agreement are approved.
- 3) The Company shall be dissolved forthwith and:
  - a) The JOLs' liquidation files shall be preserved by the JOLs for at least three years after the dissolution of the Company, after which time the JOLs shall be at liberty to destroy such liquidation files;

- b) The Company's books and records shall be preserved by the JOLs for at least three years after the dissolution of the Company, after which time the JOLs shall be at liberty to destroy such books and records; and
  - c) The JOLs shall file a Dissolution Order with the Registrar of Companies within 14 days of the filing by this Honourable Court of the Dissolution Order.
- 4) Upon dissolution of the Company, Alexander Lawson and Christopher Kennedy of A&M shall be discharged as JOLs of the Company.
- 5) The JOLs' costs of and incidental to this application shall be paid from the assets of the Company as an expense of the official liquidation.
