ORDER

UPON the petition of Suning International Limited (the **Petitioner**) dated 8 August 2024 seeking the winding up of PointGuard Ventures I, L.P. (the **Fund**) and appointment of liquidators over the Fund (the **Petition**)

AND UPON the Petitioner's Summons dated 30 September 2024 applying for leave to amend the Petition (the **Application**)

AND UPON the agreement between the Petitioner and the Fund that, without prejudice to arguments as to non-compliance, the hearing of the Petition is to be adjourned and timetabling directions made

AND UPON hearing from Counsel for the Petitioner and the Fund

IT IS HEREBY ORDERED THAT:

1. The Petitioner is granted leave to amend the Petition in the form of the draft Amended Petition appended to the Application.
2. The Petition is to be adjourned to a two-day hearing commencing on Wednesday 20 November 2024 at 10 am.
3. The Petitioner is not required to re-advertise the Petition prior to the adjourned hearing.
4. The Fund is to file and serve evidence in opposition to the Petition by 3 pm on Monday 28 October 2024.
5. The Petitioner is to file and serve reply evidence by 3 pm on Friday 8 November 2024.
6. The Petitioner is to serve a paginated hearing bundle by 3 pm on Friday 8 November 2024.
7. The parties' skeleton arguments are to be filed and exchanged by 3 pm on Thursday 14 November 2024, with the Petitioner to file at the same time the paginated hearing bundle.
8. A joint authorities bundle is to be filed by 3 pm on Friday 15 November 2024.
9. The paginated hearing bundle, skeleton arguments, and joint authorities bundle are to be filed in both hard copy and electronic format.
10. The costs of the 10 October 2024 hearing are costs in the cause.
11. Liberty to apply.
