UPON the Summons dated 17 July 2024 (the "**Summons**") of Chi Lai Man Jocelyn of Kroll (HK) Limited and Mitchell Wayne Mansfield of Kroll (Cayman) Ltd in their capacity as Joint Official Liquidators (the "**JOLs**") of Decent Zhiying (In Official Liquidation) (the "**Company**"), seeking orders and directions that the Company be dissolved

AND UPON reading the Third Affidavit of Mitchell Wayne Mansfield sworn 16 July 2024, the First Affidavit of Chi Lai Man Jocelyn sworn on 17 September 2024 and the exhibits thereto

AND UPON reading the Final Report of the JOLs dated 26 July 2024

AND UPON having heard from Counsel for the JOLs

IT IS HEREBY ORDERED that the Company be dissolved forthwith and the JOLs be discharged

AND IT IS FURTHER ORDERED AND DIRECTED THAT:

1. The JOLs' liquidation files be preserved for a period of three years after the date of the dissolution of the Company, after which time the JOLs shall be at liberty to destroy such liquidation files.
2. The Company's books and records be preserved by the JOLs for three years from the date of the dissolution of the Company and shall then be destroyed.
3. This Order shall be filed with the Registrar of Companies within 14 days from the date upon which the order is perfected.
4. The costs of the Summons be costs in the liquidation.
