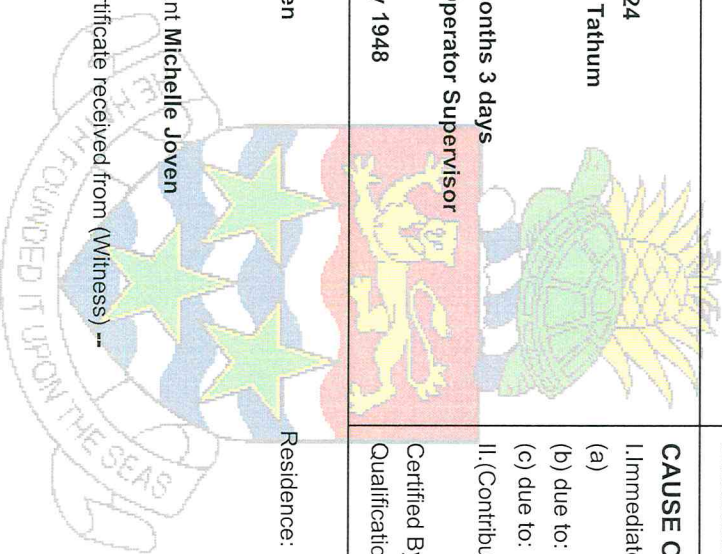

3. Estate


My Trustee shall hold the whole of my estate on trust either to retain or sell it and:
