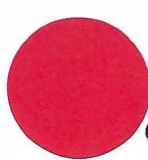
BOND

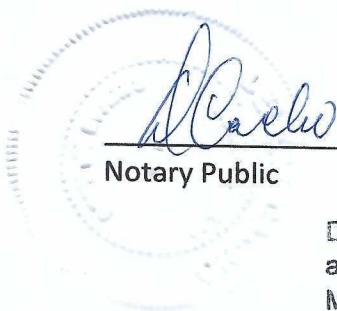
