**LET THE DEFENDANT** of c/o Conyers Trust Company (Cayman) Limited, Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman KY1-1111, Cayman Islands attend before the Judge in Chambers, at the Law Courts, George Town, Grand Cayman on the day of 2025, at o'clock on the hearing of an application by the Plaintiff of 2<sup>nd</sup> Floor, Harbour Centre, 159 Mary Street, George Town,

Grand Cayman, Cayman Islands pursuant to section 46 of the Companies Act (2025 Revision), for orders that:

- 1 Human Horizons Group Inc. (the "**Company**") shall, within seven days of the date of any order made pursuant to this Originating Summons, do all such acts (including but not limited to using its best endeavours to procure the registered agent to the Company, Conyers Trust Company (Cayman) Limited, to take any such action as is required) and sign all necessary documents to:
  - (a) rectify the Register of Members of the Company to strike out Shanghai Hongtu NEV Technology Partnership (LP)'s ("**Shanghai Hongtu**") name with an annotation that Shanghai Hongtu was incorrectly entered into the Register of Members and was never a member of the Company; and
  - (b) provide Shanghai Hongtu with a true copy of the updated Register of Members of the Company reflecting sub-paragraph (a) above.
- 2 In the event that paragraph 1 above is not complied with, within the specified time, the Plaintiff is authorised to instruct the registered agent to the Company, Conyers Trust Company (Cayman) Limited, to:
  - (a) rectify the Register of Members of the Company to strike out Shanghai Hongtu's name with an annotation that Shanghai Hongtu was incorrectly entered into the Register of Members and was never a member of the Company; and
  - (b) provide Shanghai Hongtu with a true copy of the updated Register of Members of the Company reflecting sub-paragraph (a) above.
- 3 Such further or other ancillary relief as required.

- 6 If you wish to defend claims made in the originating summons, or intend to attend the proceedings and to participate in them so far as necessary (although not necessarily in an adversarial manner) you should tick the "Yes" box in paragraph 2 of the acknowledgment of service.
- 7 For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
- 8 Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Originating Summons)".
- 9 Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
- 10 Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
